In April 2015, The Foundation led a special mission to Nigeria during which a surgical team performed 26 complex joint replacements and long bone surgeries on indigent patients. The Foundation also donated and installed the SIGN Fracture Care system at the Anambra State Teaching University Hospital. The SIGN system allows local surgeons at that facility to repair long bone fractures in a sustainable, efficient and cost-effective basis.

In 2015, the Foundation hired OMMA healthcare to assist in developing and planning for a world class hospital located in Nigeria. In January of 2005, the Foundation secured land for establishment of the hospital.
